DEVELOPMENT LEVY

The Development Levy for 2023 is as follows:

INFORMATION TECHNOLOGY LEVY

An Information Technology Levy will be applicable with effect from 1 January 2023 as follows:

- R 200 per Junior Primary Learner per annum (Grade 1 to Grade 3)
- R 400 per Senior Primary Learner per annum (Grade 4 to Grade 7)
- R 600 per High School Learner per annum (Grade 8 to Grade 12)

SUBJECT LEVIES

The following Subject Levies will be applicable with effect from 1 January 2023 as follows:

- Geography R 1 250 per Learner per annum (Grade 10 & Grade 11)
- EGD R 500 per Learner per annum (Grade 10 to Grade 12)
- Consumer Studies R 500 per Learner per annum (Grade 10 to Grade 12)
- Further Studies English R 800 per Learner per annum
- Further Studies Maths R 800 per Learner per annum

INDEPENDENT EXAMINATION BOARD (IEB) FEES (SPLIT OVER 2 YEARS)

- Grade 11 R 4 200.00 per annum
- Grade 12 R 4 200.00 per annum
